Minutes for the Annual Convention Held on Friday, September 23, 2022

Opening Session: 7:00 - 7:45 pm

Welcome:

Rob Lemke, Vice President, welcomed all members in attendance and thanked all for participating in this year's Annual Convention and a thank you to Hofstra University for allowing us to use their facility.

President's Report by Alex Cuozzo:

Due to the COVID pandemic, 2021 showed a decline in membership and available championship events. In 2022, the first indoor event was held after 14 months and membership did increase from 2021, but not to the level of 2020. This demonstrates that membership is tied to putting on events. National is providing a Grow to Impact Grant of \$5,000 to assist in membership growth. Donations of \$10,000 were received in the spring and the fall. Some of the proceeds were used to send a team to the Empire State Games. At this event, Long Island's Men's Team placed first overall. USATF-LI was included in the committee meetings for Oregon22 with USATF President Vin Lananna. The Cow Harbor 10k race was accepted as a national event for the first time in its history and USATF-LI will provide officials for this venue. USATF-LI received full accreditation and will be able to provide full representation to the National Annual Meeting on December 1, 2022 – December 4, 2022 in Orlando, FL. Today, we are electing delegates to this meeting, as well as, executive board positions.

Presentation of 2022 Bank Balance and Proposed 2023 Budget by Gary Westerfield, Treasurer:

A motion to continue banking with Citibank was entered, seconded, and passed.

The current bank balance of \$42,152 includes two donations of \$10,000 each from Glen Wolther and AllAround Foods and a \$5,000 from the Simons Foundation for Race Walking.
