Budget & Finance:

Race Walking: Gary Westerfield reported that Maria Michta-Coffey placed second at the 2023 USATF 35k Race Walk Championship in Santee, CA on January 15, 2023. She will compete at the USATF Women's 1 Mile Race Walk at the Millrose Games on February 11, 2023 and the USATF Indoor 3000m Championships on February 16, 2023 in Albuquerque, NM.
