*Minutes:* Minutes from the USATF-LI Convention on September 30, 2023 were approved as amended. Minutes from the Board Meetings of October 2, 2023 and November 6, 2023 were approved.

**Budget & Finance:** Gary Westerfield submitted information: Bank Balance at Citibank as of November 30, 2023 is \$40,142; the bank balance is \$38,711 (does not include USATF Meeting expenses). There are outstanding income and expenses for the cross-country event. There are outstanding expenses for the USATF Meeting. Expenses are itemized on the USATF-LI credit card and airfare receipts, not purchased on the credit card, should be submitted to the Gary Westerfield for reimbursement. Reimbursement for the USATF Meeting was budgeted for 13 delegates at \$150/delegate (Total \$1,950), but only 8 delegates attended. Therefore, the reimbursement allocation per delegate is approximately \$243.

USATF National Convention (November 30, 2023 – December 3, 2023) Review: Alex Cuozzo reported that the vote at the Convention requires a 2/3 majority, but when decision goes to the National Board, the decision is in an advisory capacity only which the National Board can choose to ignore. Only USATF Board Members (President and Christopher Pasko) are voted in by the general membership. To be a delegate, an individual must have an athlete and/or coach designation. Individual workshops are summarized at the end of these minutes.

# **USATF National Meeting Workshop Summaries:**

*Master and Women LDR:* Lori Mangual reported that discussion centered around gun time versus chip time and awards. Lori Mangual participated in the Masters Grand Prix Cross-Country Championship in Boca Raton, FL and placed 2<sup>nd</sup> in her age group. 2024's event will take place in Boulder, CO.

*Youth:* Liz Henry reported that discussions centered around voting on new rules, grants, SafeSport requirements for youth, coaching courses for Levels I and II, entry fees, and anti-doping and first aid requirements for officials.

Race Walking: Pamela Lee reported that discussions centered around approval of standards and the upcoming Olympic Mixed Race Walk Relay.

Master Track & Field: Rob Lemke reported that discussions centered around minor rule changes and future events. Regional events will take place in Providence, RI (USATF Masters Indoor Track & Field Championships January 28, 2024), Landover, MD, and Ocean Breeze Athletic Complex in Staten Island, NY (USATF NY Open and Masters Indoor Track & Field Championships February 24, 2024). Future sites include 2024 USATF Masters Indoor Track and Field Championships on March 21-24, 2024 in Chicago, IL, 2025 USATF Masters Indoor Track and Field Championships on February 20-23, 2025 in Gainesville, FL, 2025 World Masters Indoor Track and Field Championships two weeks later in Gainesville, FL, 2026 Masters Indoor Track and Field Championships in March 2026 in Indianapolis, IL, and 2026 Masters Outdoor Track and Field Championships in August 2026 in Geneva, Ohio. Kathy Martin was voted as 2024 Athlete of the Year.

Associations: Alex Cuozzo reported on various discussions. Association delegates had to qualify as athlete, coach, or specified designation. USATF-LI ranked in the top 15 in all classifications and placed 19<sup>th</sup> best association in the country. Term limits will apply to all executive committees and will senior level positions will expire at the end of 2024. The World Athletics Technical Rulebook has been adopted s the default rulebook for USATF meets. 50% of all sponsorships will go to World Athletics.
