### Old Business:

USATF National Convention, Orlando, FL, December 5, 2024 – December 8, 2024 review:

Alex Cuozzo reported that the meeting was a nice affair, weather was chilly, and Curt Claussen was elected National President by 56.8%.

Associations: Attending his first Annual Meeting, Michael Frazer, reported that the session was informative. This may be the last in-person Annual Meeting, although other options may be forthcoming. Rob Lemke attended the Association workshop on finance. There seems some confusion regarding the 501(c) status of Associations. Further documentation is necessary.

*Track & Field:* Women's – Pamela Lee reported that a new chair and vice chair were elected. Also attended US Women's Track Coaches Focus Group. This stand-alone organization is offering scholarships for Levels 1, 2, and 3 Education and for mentors of female U20 (ages 16-19) athletes. Information can be found at new website: USWOMENSTCA.COM.

*LDR:* Women's – Lori Mangual reported that a new chair was elected. Paris Olympics and upcoming races were discussed.

Race Walk: Sue Michta reported that new chairs were elected. Organizational and revamping procedures for voting were tabled. The Committee is trying to set up a revised rating system based on points leading up to the Summer Olympics in Los Angeles to gain more respect for officials.

Master Athletics: Rob Lemke reported that new chairs were elected. The eastern region has not hosted a regional masters outdoor meet and such an event could be staged in early June. A possible location is Farmingdale College.

Para-Athletics: Steven Cuomo reported that there was an announcement to combine para-athletics into National. Officials: Rose Mangogna reported that officials are required to be certified for the quadrennial term leading up to the Los Angeles Olympics. Officials' awards were given to Sue Michta for U20 Race Walk and to Rose Mangogna for Masters.

*USATF Para-Athletics*. It has been announced that Para-Athletics officially will combine with the National Team. Organizing and producing athletes in this category is important.

## **Standing Sport Committees:**

*Track & Field:* Sanction has been completed for the New Year's Eve Clinic. USATF-LI O/M Indoor Championships is scheduled for March 1, 2025 at St. Anthony's HS.

*LDR:* Alex Cuozzo reported that the Grand Prix Road Series ended yesterday with the Santa 5k which was well-attended with about 650 finishers. Final standings will be completed in about a week. Approximately one-half of the prize money will be allocated. The balance will go to USATF-LI. Application for the 2025 GPRS is going forward. USATF Grow to Impact Grants may continue in the future. The current grant period existed for three years. Elitefeats has been chosen to administer funds from the new sponsor to various running clubs. The next LDR meeting is scheduled for December 16, 2024.

Race Walking: A one-mile race walk is scheduled for the January 19, 2024 USATF-LI Youth Championships.

*Mountain Ultra & Trail:* Ron Nardo reported that Sayville RC is hosting A Backyard Ultra on December 14-15, 2024. Each participant must complete a loop of 4.167 miles once every hour on the hour for 24 hours and is eliminated if cannot complete the loop in one hour. Everyone is DNF until last participant is remaining.

*Master Athletics:* Looking for good participation at the January 1, 2025 indoor meet. Rob Lemke reported that the World Masters Indoor Championships will take place on March 23-25, 2025 in Gainesville, FL.

*Youth:* The USATF-LI Youth Championships is scheduled for January 1, 2025. Apply through Elitefeats. The first event will start at 12:00 pm. Since the 1500m RW is the high school distance, the one-mile RW will be removed as an event from the flyer and replaced by the 1500m distance.
